- 1) Abu (Chair) introduced the meeting.
 - Sarah Khan is the new Sergeant on the team. James Fraser is the PC and Amanda the PCSO.
 - Caroline Watts from Tower Hamlets will be leaving the TH Team on 18th September.

<u>Current Issues and Problems in the Area</u>

- 2) AirBnB Parties this has been causing more problems recently as they are being used to have parties. The SNT is having difficulty contacting landlords. There are complicated rules about enforcing licensing airBnB.
 - Please contact Caroline or PC James if you know where this is happening. Disturbances like this can be addressed through the noise nuisance service (8pm to 3.30am Thurs-Sunday Tel: 020 7364 5000 hold to speak to the call handler).
- 3) There is an **ASB reporting flyer** that Caroline will pass on to the chair

- 4) There was concern that:
 - Police do not often seem to respond to reports of groups of young people gathering.
 This should be a priority during the pandemic.
 - When residents report issues to the TH ASB team or police they don't get any feedback or response.
 - There is a concern that because there is little police response, some residents have taken investigation into their own hands eg bike theft

Police and TH explained that they have to prioritise their resources and cannot do everything they want to.

5) **Bike thefts** – these have increased considerably but even when they are caught on camera identification is difficult because everyone is wearing masks.

The thieves are known locally and have been seen selling them on at Chrisp Street Market.

6) Stabbings -

- a) The current incidents have been targeted on specific individuals involved in crime and are not just random attacks.
- b) These violent incidents are related to drug and gang issues and are about territory or money.
- c) None of the recent attacks have been in our ward. They have taken place at Crossharbour DLR, Blackwall, and at Nisa/ Manchester Road.
- d) Patrols have been noticeably present in the parks acting as a deterrent.
- e) James will ask for extra street patrols to reassure residents.
- 7) Canary Wharf Ward is one of the **safest wards** in the Borough there is only 1 ongoing TH ASB case in this ward at the moment.
 - There do need to be more cameras, and there can be temporary ones put in if the need is identified.
- 8) **NOX canisters** The ASB connected with the dumping of the canisters is also a problem. Please use the "Love Your Neighbourhood" app (LYN) to map these incidents to help build up the picture for TH.
- 9) **Graffiti** this needs to be reported through the LYN app. If it is offensive it will be removed within 48 hours.

10) Concerns to be considered for prioritising:

- Millharbour and the streets off them are areas that need highlighting for ASB
- Drug dealing by the cinema in Hertsmere Road,
- Byng St/Manila Street drug dealing
- Bicycle Thefts
- Marlin apartments AirBnB in Byng Street

• Engine Revving in Cassilis Road

3 agreed Priorities:

- a) ASB in Millharbour / West India Quay /
- b) Bicycle thefts and selling
- c) AirBnB partying
- 11) **Neighbourhood Watch** this will be a big help to the police and ASB teams for information sharing.

Groups need to be manageable so not too big and may be a tower block or a few blocks /streets.

Information about setting it up will be circulated to the panel later.

The national NW group is currently talking to the police in TH about liaising with them.

12) The police were very effective in stopping the tunnel run.

13) The ward panel way forward:


